DOVER SCHOOL DISTRICT KINDERGARTEN and FIRST GRADE REGISTRATION

Dear Parents/Guardians,

The Dover elementary schools are now accepting appointments for Kindergarten and first grade registrations for new, incoming students, for the 2018-2019 school year. In order for students to be eligible to register, students must be turning 5 years of age on or before September 30, 2018 for Kindergarten, and 6 years of age on or before September 30, 2018 for first grade. You will find below the appointment dates and times for your local neighborhood schools, as well as contact information. *Please note that registration is by appointment only.*

To complete the registration process, parents/guardians **must** bring the following documents with them to their appointment:

- **Copy of Birth Certificate**
- **Proof of Residency** (must state physical address, i.e., utility statement (electric, phone, cable), or if renting, a copy of your lease)
- **Proof of Immunization & Physical Exam** (please refer to the backside of this paper for laws regarding immunization)
- **Court Documents** (if any, stating custodial rights)

As part of the registration process, those parents registering children for **KINDERGARTEN** (*not Grade 1*), will be asked to make an additional appointment for their child to partake in an early-screening skills check. This appointment will take 1 hour, and will assist teachers in meeting students' individual needs.

Listed below are the **NH STATE LAWS** regarding immunizations (RSA 200:38). The Dover School District cannot allow your child to begin school until we receive documented proof that the laws have been met, prior to school entrance. **ALL CHILDREN SHALL BE IMMUNIZED PRIOR TO SCHOOL ENTRANCE (RSA 141-C:20A).**

MEDICAL EXAMINATION	A <u>COMPLETE</u> medical examination by a licensed physician, upon or prior to, entrance into the school system, and thereafter, as often as deemed necessary by the local school authorities. (RSA 200:32)
DPT	(diphtheria, pertussis and tetanus) or DT (diphtheria and tetanus) A minimum of 4 doses – a dose must have been given on or after the fourth birthday, or a total of 5 doses, regardless of age.
POLIO	A minimum of 3 doses – a dose must have been given on or after the fourth birthday, or 4 doses of OPV or IPV, regardless of age.
MMR	(measles, mumps, and rubella) 2 doses – 1 st dose on or after the first birthday, and a 2 nd dose at least 28 days after the 1 st dose.
HEPATITIS B	Children must have completed or started the Hepatitis B series of 3 doses. It is strongly recommended the series be completed before September.
VARICELLA	2 doses – 1 st dose on or after the first birthday, and a 2 nd dose at least 28 days after the 1 st dose, OR documentation of immunity, by confirming laboratory test results.

(For all minimum intervals and age requirements, a 4-day grace period is acceptable)
